#### 1. INFORMATION COVERED BY THIS POLICY

We may collect following information from You and this Policy applies to all such information collected and processed by us:

- 1.1. Personal Information is the information related to you, or a combination of pieces of information that could reasonably allow you to be identified. Personal information may consist of including but not limiting to, full name, personal contact numbers, residential address, email address, gender, age, nationality, date and place of birth, marital status, PAN, registration number, user id, Passport details (including number, issue date, issue location and expiration date) and Unique ID number to the extent permitted or required by applicable law, product preferences, billing name, billing address, purchasing history and spending behaviour, driving license, Election Card, Communication preferences, your website usage, IP-address, browser type and operating system.   - (E) operate, evaluate and improve our business, including by:

- developing new goods and services and determining the effectiveness of our advertising; and
- tracking and analysing your use of goods, materials and/or services;
- 2.1.14. track, document and analyse your line of sponsorship;
- 2.1.15. assessing your performance under your registration or business relationship with us;
- 2.1.16. provide information to you related to your purchases and under the loyalty program;
- 2.1.17. provide business performance information to you, provide your name, address, telephone number or e-mail address to people both your upline and your downline in the chain.
- 2.1.18. provide business performance information to you (*e.g.*, information on your line of sponsorship, purchase volumes, earned bonuses, levels of awards, your referring direct seller / consumer or, and your upline direct seller as per the marketing plan);
  - If you choose not to provide your personal data or withdraw consent in writing subsequently, we may not be able to provide the above services and reserve the right to terminate any contract with you.

## 2.2. SHARING OF INFORMATION/DATA

Company does not sell, rent or trade or publish your personal and sensitive data except as required by law. Company may share your personal and sensitive data only with:

- 2.2.5. Third party service providers: service providers supplying services to support, improve, our services. We also use service providers to help speed up content delivery to you in your region using acceleration points and content delivery networks; and to provide location and mapping data. Any third party (selected by us) with whom we share user data will provide the same or equal protection of user data as stated in this Policy.
